We are still about 8 inches above the normal high-water mark so asking we all observe 5 mph max within 300'. It's probably not a bad practice during normal times, as it protects our shoreline.

Treatment was done on August 9th by PLM Lake & Management Corp. They said we should see a difference within 7-10 days.

Thanks for your patience in getting this done. The state shutdown added to the delay but PLM says the treatment should be very effective.
